

## **CADTH Pre-submission, Pipeline, and Reconsideration Meeting Dates**

- CADTH uses standardized dates and times for pre-submission meetings, pipeline meetings, and reconsideration meetings. This approach streamlines the process and eases the administrative burden for CADTH and industry.
- Meetings are only offered in the timeslots provided in the table below (no exceptions will be made). Meetings will be assigned on a first-come, first-served basis.
- Presubmission meetings are a maximum of 1 hour or 1.5 hours if the meeting will include discussion regarding a time-limited recommendation. Pipeline meetings are a maximum of 1.5 hours.
- When completing the pre-submission meeting and reconsideration request forms, the sponsor must identify one or more preferred dates from the list in the table below. Sponsors are encouraged to arrange pre-submission meetings well in advance of the targeted date for filing the application.
