¹ The date of receipt is considered day zero for the purpose of calculating the 10 business day targeted timeframe for the initial screening of the category 1 requirements. If the applicant is targeting a specific CDEC meeting, they are encouraged to file the submission or resubmission early in the window to allow time for addressing any potential deficiencies in the requirements.

² Submissions/resubmissions are typically initiated within 10 business days of being accepted for review by CADTH.

³ For submissions that are filed on a pre-NOC basis, the embargoed CDEC recommendation will not be released until CADTH has received a copy of all required information, including a copy of the NOC or NOC/c.

⁴ The embargoed CDEC recommendation will not be released until all category 2 requirements have been received.

⁵ If the manufacturer does not file a request for reconsideration or the drug plans have not filed a request for clarification.
