Key Messages

- We did not find any evidence-based guidelines regarding the use of pharmacological and psychological interventions for the treatment of adults with post-traumatic stress disorder in correctional settings.
- We identified other references on this topic that may be of interest; these are listed in the appendix.

Research Question

What are the evidence-based guidelines regarding the use of pharmacological and psychological interventions for the treatment of adults with post-traumatic stress disorder in correctional settings?

Methods

Literature Search Methods

A limited literature search was conducted by an information specialist on key resources including MEDLINE, the Cochrane Database of Systematic Reviews, the International HTA Database, the websites of Canadian and major international health technology agencies, as well as a focused internet search. The search strategy comprised both controlled vocabulary, such as the National Library of Medicine's MeSH (Medical Subject Headings), and keywords. The main search concepts were PTSD and correctional settings. CADTH-developed search filters were applied to limit retrieval to guidelines. Where possible, retrieval was limited to humans. The search was completed on January 31, 2023, and limited to English-language documents published since January 1, 2018. Internet links were provided, where available.

Selection Criteria

One reviewer screened literature search results (titles and abstracts) and selected publications according to the inclusion criteria presented in <u>Table 1</u>. Full texts of study publications were not reviewed. Open access full-text versions of evidence-based guidelines were reviewed when available.

Intervention	Pharmacological (e.g., antidepressants, ketamine, clonidine) and psychological (e.g., cognitive behavioural therapy, narrative exposure therapy) interventions

Outcomes	Recommendations regarding best practices (e.g., appropriate patient populations, guidance as to which therapies should be used [e.g., as first- or second-line treatments], treatment protocols [e.g., dosing and frequency], recommended safeguards, strategies to mitigate harms, adverse events, and misuse)
