## **Key Messages**

- We did not find any studies about the clinical effectiveness of chiropractic functional neurology therapies for the treatment of neurological or psychiatric conditions.

## **Research Question**

What is the clinical effectiveness of chiropractic functional neurology therapies for the treatment of neurological or psychiatric conditions?

## **Methods**

## **Literature Search Methods**

An information specialist conducted a literature search on key resources including MEDLINE, the Cumulative Index to Nursing and Allied Health Literature (CINAHL), Scopus, the Index to Chiropractic Literature (ICL), the Cochrane Database of Systematic Reviews, the International HTA Database, the websites of Canadian and major international health technology agencies, as well as a focused internet search. The search approach was customized to retrieve a limited set of results, balancing comprehensiveness with relevancy. The search strategy comprised both controlled vocabulary, such as the National Library of Medicine's MeSH (Medical Subject Headings), and keywords. Search concepts were developed based on the elements of the research questions and selection criteria. The main search concept was functional neurology. The search was completed on April 18, 2023, and limited to English-language documents published since January 1, 2018. Internet links were provided, where available.

## Selection Criteria and Summary Methods

One reviewer screened literature search results (titles and abstracts) and selected publications according to the inclusion criteria presented in <u>Table 1</u>. Full texts of study publications were not reviewed. The Overall Summary of Findings was based on information available in the abstracts of selected publications.

Table 1: Selection Criteria

Criteria	Description
Population	Adults with neurological or psychiatric conditions (e.g., concussions and post-concussion syndrome, headaches and migraines, neuropathy, depression)
Intervention	Chiropractic functional neurology therapies as an adjunct to usual care
Comparator	Usual care alone (e.g., pharmacotherapy, physical therapy)
Outcomes	Clinical benefits (e.g., pain, function, psychological symptoms, quality of life, patient satisfaction) and harms (e.g., adverse events)



Criteria	Description
Study designs	Health technology assessments, systematic reviews, randomized controlled trials, nonrandomized studies

## Results

No relevant health technology assessments, systematic reviews, randomized controlled trials, or nonrandomized studies were identified regarding the clinical effectiveness of chiropractic functional neurology therapies for the treatment of neurological or psychiatric conditions.

# **Overall Summary of Findings**
